CONDITIONS OF USE

The temperature of the adhesive, the environment, the sub-floor and the floor-covering should ideally be between 10°C and 25 °C.

At lower temperatures (5-10°C), the viscosity increases, and the reaction is slowed down, thus the curing time becomes longer. At higher temperatures (25-35°C), the viscosity of the adhesive decreases. It may appear very liquid; thus a higher amount of adhesive is to be applied. Also, the reaction between the two components is very fast. The pot life is reduced and the installation should proceed very quickly.

The substrates may be moist, but not soaking wet (no running water on the surface). Otherwise the water may create a film forming a barrier between the adhesive and the backing of the turf, preventing the bonding of the turf

INSTRUCTION FOR USE

The surface to be bonded must be cohesive, sound, clean, and free of grease and contaminants.

Mix adhesive and hardener thoroughly to a homogenous mixture with an electric driller. Do not use those parts of the adhesive which stick at the edges. It is better to re-fill the mixture into a clean bucket and stir again well. Do only mix the amount of adhesive which can be consumed within approx. 50 minutes. Higher temperatures accelerate the hardening of the mixture, lower temperatures delay it.

The synthetic turf floor-covering has to be laid on the sub-floor, the seam is to be cut and the floor-covering is to be folded back. The adhesive is to be applied on the polyester seaming tape. The amount of the adhesive depends on the backing structure of the floor-covering.

Right after the adhesive has been applied on the tape, the floor-covering can be installed within approx. 60 min. (23 °C and 65% relative air humidity, freshly made mixture). The installation time depends on the environmental temperature, air humidity and sub-floor temperature. If the floor-covering is installed later than 60 min., the bonding power cannot be guaranteed. After the synthetic turf floor-covering has been installed, please rub it or use a barrel to roll it in. The same procedure applies to the installation of game line marking.

Remarks

Please use swiftclean®9694 to clean tools and adhesive stains before hardening. Already solid adhesive can only be removed mechanically. The hardener is moisture-sensitive, thus the bucket needs to be closed tightly and stored at a dry place.

Wear suitable protection gloves when applying the adhesive because the reacting components of the adhesive deeply penetrate the skin and are difficult to remove. It is recommended to wear protective gloves as both components (A and B) may penetrate the skin pores and are difficult to remove.
